This agreement will be governed by the provisions of Law 11/2019, on volunteering in the Balearic Islands and, in matters not provided for therein, by the provisions of this incorporation agreement.

Both parties accept that this agreement does not entail the reduction of paid posts offered by the entity or the substitution of any public service and that, in no way, does the relationship between both parties constitute an employment relationship subject to current labor regulations.

### 3. Information

That the VOLUNTEER declares that he/she has been duly informed of the content of the Statutes of IbizaPreservation and of the program in which he/she will participate thus agreeing to perform the task/s as set out in the description of them.

## 4. Conditions of the activities to be performed by the volunteer

- a) The volunteer knows and expressly accepts that his/her activity will not be subject to any remuneration and undertakes to carry it out responsibly and confidentially, committing to give sufficient notice in order to be replaced by another volunteer in the case that fulfilment of the agreed activity becomes impossible to fulfill.
